This quarter, we launched the "Dollar-a-Day Challenge", partnering with Fidelity and Stockpile. Stockpile offered \$5 free for YIS kids to start investing and did a great video interview with us to promote the partnership. Their app, partial stock trades, and custodial accounts make it a perfect platform.

We also opened scholarship applications for kids to receive 1x1 matching funds. We look forward to announcing the winners for the sponsorships as we



received some really inspiring essays from the kids. It's great to see investing concepts we teach go from theory to practice, as kids actually starting to save and invest and learn life-long habits.

Fundraising

This quarter we raised \$23,000, of which \$6,500 came from the golf

fundraiser. We also carried out an end-of-the-year giving campaign, as well we submitted two additional grants, including one for the Adobe Foundation.

We're looking forward to our first Gala / Investment Symposium event in New York City on May 3, the evening before the Stock Pitch Finals. BNY Melon has donated their large atrium for us to use and it'll be a great event to build awareness, raise money and have a culmination event to highlight the YIS kids achievements during the year.

With an East Coast and West Coast fundraising events coming together, we envision how this will be a great structure going forward, with one major event on each coast, each year. We'll need the help from our board members and other volunteers to put on these events, but we see this as a sustainable funding base for YIS going forward.

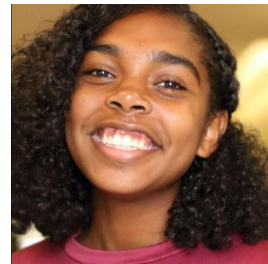
