

Letter from YIS Founder & President, James Fletcher, CFA



There is so much to be proud of this year at Young Investors Society! Our program has now grown to 2,390 schools in 80 countries around the world.

I think when we look back at this 9 th year of YIS in the history of the organization, it'll be remembered as the year we launched the GYIS Summit. We upgraded our flagship event from the Global Stock Pitch Competition to the Global Youth Investment Summit (GYIS) and moved it back to New York City. The new event brings a new mentality: more activities and competitions than just the Stock Pitch Competition, more networking opportunities, more kids invited, and more fun all around! This year, we had a great turnout of over 150 kids attending in person in addition to all the parents and chaperones, over 120 financial professionals as judges and workshop teachers. Special thanks to the YIS team for pulling it off, I specifically want to thank Christine, Maria, and Jayme for their inspiring efforts.

We also made great strides this year at YIS in the revamp of the Dollar-A-Day Challenge, to increase the number of kids that get sponsorships by giving out awards on a monthly basis. The Mid-Year Competition was changed to an Online Knowledge Bowl, which greatly increased student participation. And we started doing quarterly Fireside Chats where we heard from numerous incredible speakers who shared stories and advice. All of these I felt were great improvements to the YIS programs and impact!

We also made tremendous strides this year with regards to corporate partnerships and fundraising. It is exciting to say that this year YIS was sponsored by many incredible organizations including Bloomberg Philanthropies, Goldman Sachs, Grandeur Peak, Capital Group, Bank of America, PIMCO, Blackrock, Fidelity, JP Morgan, Neuberger Berman, MFS, New York Life Investments, American Century, Natixis, Nuveen and AMG among others. Letter from YIS Chief Operating Officer, Christine Tobin



This year has been full of amazing progress and continued growth. Young Investors Society has met 100% of the membership and program goals for the year including exceeding our total schools & student goal as well as Dollar-A-Day Challenge and fundraising goals for the year.

We are beginning to see the impact of our growth with the first Global Youth Investment Summit which served over 150 students as well as an increase in the Access Initiative. We can proudly announce that 21% of our total students are served through the Access Initiative. I can proudly say that we are positioned for a future where every high school student has access to FREE, quality, online financial education.

We introduced Fireside Chats where students get to learn personal stories, career advice, and ask questions to a variety of industry professionals. We have had great feedback from the students that they thoroughly enjoyed being able to network and interact with finance professionals.

We expanded our Dollar-A-Day Challenge program to include a personal finance quiz and monthly opportunities for students to apply which led to an increase in participation of 79%. We also doubled the amount of scholarships to students giving scholarship matches to 200 students this year.

We successfully held an online Giving Tuesday Fundraising Campaign and the first Money Skills Teen Conference in Southern California and Utah this year. We continue to secure multi-year corporate sponsorships from Bloomberg Philanthropy and Grandeur Peak to support the Access Initiative. We are amazed at the generosity and support from our YIS Boards and donors as well as corporate sponsors this year for our Invest in the Future Gala which hosted over 200 people and had sponsorships from over 20 investment firms including Bank of America, Goldman Sachs, Fidelity, Capital Group, JP Morgan, BlackRock, Pimco, and many more.





Bloomberg Connecting Futures Networking Event




We kicked off the 2023-2024 Global Youth Investment Summit with an amazing Connecting Futures Event sponsored by Bloomberg.

Global Youth Investment Summit



The Global Youth Investment Summit was held at Cornell Tech University on Roosevelt Island in New York. This 2-day event was filled with finance workshops, industry speakers from Microsoft & Goldman Sachs, featured an AI case study competition, personal finance games, and our 2024 Global Stock Pitch Competition.

This event served over 150 students from 21 states and 9 countries including 98 stock pitch teams.

85 professionals from over 40 financial firms participated as stock pitch and case study judges, speakers, and event volunteers.




